The inspection team met the Principal, visited entire college complex, class rooms, Computer labs etc. The team also met the faculty members of the college. The team had a prolong discussion with the Principal, faculty members and after thread bare discussion, the team comes to the following observations, suggestions and recommendations.

**OBSERVATIONS:-**

**Accommodation:-** College has sufficient space, class rooms to start the proposed courses(theory classes). However, for Spoken English course, language lab is not available.

**Books:-**

For Political Science – 170 nos. of books are available  
For English – 256 nos. of books are available  
For Management 70 nos. of books are available

**Reading room :-** 2 reading rooms which can accommodate 100+20 students.

**Faculty:-** College authority has submitted a panel of teaching faculty with three teachers for English, two for Political Science and two for Management.

### SUGGESTIONS:-


1. From the next academic years i.e from 2011-2012, number of class rooms for theory classes of Political Science(H), BBA and Spoken English should be increased.
2. Language Lab for the Spoken English classes should be set up.
3. For BBA Course, separate Computer Lab with sufficient nos. of computers are required.
4. More books should be purchased following the existing syllabus.
5. At least 2 regular and 2 Part time teachers for Honours courses and BBA courses are required.


