Decision taken after discussion:

The meeting was chaired by the Chairman of the Finance Committee. The Chairman welcomed all the members in the meeting. The previous minutes were read and confirmed by all the members.

The following resolutions were taken:

- 1. The committee discussed the need for an extension to accommodate the growing number of students and staff. It was decided to proceed with obtaining quotes from construction companies and to review the feasibility of the project.
- 2. The importance of integrating modern teaching tools into classrooms was emphasized. A budget allocation was discussed, and the procurement process will begin promptly to ensure timely installation.
- 3. The need for upgrading desktop PCs in various departments was acknowledged. The IT department will prepare a list of required specifications and initiate the procurement process accordingly.
- 4. Recognizing the importance of uninterrupted power supply for electronic devices, especially Smart Boards, the necessity for UPS units was discussed. The procurement team will research suitable UPS options and present them for approval.
- Security concerns were raised, prompting discussion on the installation of CCTV cameras across the premises. A security assessment will be conducted to determine optimal camera placements and budget requirements.
